Course Goals – 122 Theological Heritage 1: Introduction

This course introduces the student to theological reflection in the Wesleyan tradition. Basic terms, tasks and methods of Christian theology will be introduced. Representative classical themes will be defined and illustrated. The course provides a foundation for further historical and theological study.

Students will be able to:

1. Examine their understanding of faith, sin, salvation, grace, and the place of doctrine in the life of the church.

2. Use and understand classical theological terms and themes.

3. Critically consider the sources of theological reflection, including scripture, tradition, experience, and reason.

4. Reflect theologically as a resource for pastoral ministry.

Please note: Each course has **assigned texts.** Students are required to read them, use them in their assignments, and are accountable in the classroom for any discussion or presentation of materials. **Reference books** are also required; assignments presume the use of the reference materials; although they are not classroom texts. Assigned texts and reference books help the student to build their own library. **Supplemental texts** are valuable, but optional texts.

Advance Assignments

Advance assignments **must** be completed by the due date noted.

1. Write a 5 page paper exploring the Wesleyan Way of Salvation and the distinctive Wesleyan doctrines pertaining to salvation. Due March 6. Read Campbell Introduction, ch. 3 & 4; Gonzalez & Perez pp. 9-32, 55-75, 90-96. Wesley's Sermons: 54. The Scripture Way of Salvation; 2. Original Sin; 3. Free Grace; 13 Salvation by Faith; 14. Justification by Faith; 16. The New Birth; 17. The Marks of the New Birth; 40. Catholic Spirit; 57. Christian Perfection; Book of Discipline 2016 para. 102-105.

Scoring

- 20% Identify doctrines pertaining to salvation
- 20% discussing prevenient grace
- 20% discussing justification and new birth
- 20% discussing sanctification and the doctrine of Christian perfection
- 20% apply the doctrines to your present ministry

2. Write 3 pages based on ch. 5 of Campbell exploring your theology of local pastors in the ministry of the church. Due April 10. Read Campbell ch. 5; Gonzalez & Perez pp. 97-118; Wesley Sermon 115 The Ministerial Office; Book of Discipline 2016 ch. 2; Wesley's Sermon 8. The Means of Grace

- 33% discussing the ordained ministry of both elders and deacons
- 33% discussing the means of grace, especially referencing Wesley's sermon "The Means of Grace"
- 33% discussing the ministerial offices including Local Pastor

- Write a 5 page paper on who is Jesus Christ. The paper should cover the person and work of Jesus Christ. Due May 1. Read Campbell Ch. 2; Gonzalez & Perez pp. 77-96; Book of Discipline 2016 para. 102-105; Wesley Sermon 15 The Lord Our Righteousness.
 - 25% discussing the person of Jesus Christ
 - 25% identifying and discussing Christological doctrines
 - 25% discussing the work of Jesus Christ
 - 25% applying the question, "Who is Jesus?" to your own ministry setting
- 4. Final 5 page reflection paper synthesizing all you have learned from this class. What difference does your understanding of these important doctrines make in your life and ministry? Due May 20.
 - 20% doctrines pertaining to salvation
 - 20% doctrines pertaining to pastoral theology
 - 20% discussion demonstrating a robust Christology
 - 20% integration of class discussions
 - 20% integration of theology with your ministry context

Note: The writing manual approved by Perkins COSS is: Kate Turabian, A Manual for Writers of Term Papers, Theses, and Dissertations, 7th Edition.

All papers must be printed in 12 point font, preferably in Times New Roman, double spaced with either footnotes or end notes. Papers must include proper citations and page numbers for references. Please submit written work in a MS Word doc format. See the above writing manual for questions on how to write. In the event of a difficulty, a student may request an extension from the instructor prior to the due date for advance assignments. This request may be made via email and if granted, may extend to a 3 week maximum. If assignments are not completed, the student may receive a grade of incomplete.
